TRUST DEED

This deed of Trust is executed at Ambala City on this 20<sup>th</sup> of December ,2006 by Shri Ramesh Kumar S/o Sh. Om Parkash r/o 45-A, Sharda Nagar Ambala City.

Whereas the above said settler: Sh. Ramesh Kumar S/o Sh. Om Parkash r/o 45-A, Sharda Nagar Ambala City is desirous to create a Trust for the educational/charitable purposes.

Now, therefore, this deed witnesseth as under:-

1. Name

The Trust shall be called "SHIV GOURAKH NATH EDUCATIONAL TRUST" (hereinafter referred to as the 'Trust').

2. OFFICE

a) The Head Office of the Trust shall be HARTRON BUILDING AGGARSAIN CHOWK AMBALA CITY. It can be shifted to any other place as decided by the trust from time to time.

anywhere within the territory of Indian Union.

c) State level branch (es), Office(s) and District sub-office(s) shall function in accordance with the instructions issued from Head Office from time to time.

### 3. AIMS AND OBJECTS OF THE TRUST:

(a) To work for upliftment of Education ( Technical Education, Medical Education, General Education etc. ) and prosperity of Humanity by establishing different Educational, Research & Training Institutions under prescribed syllabus of the State and Central Govts. The institutions can be opened in any state under any name as per resolution passed by the Founder Trustees through its meeting by majority votes.

(b) To work for the upliftment of the poor sections of the society , to give scholarships to the needy, to arrange Marriages of poor girls, to open old age homes etc.

(c) To possess properties and funds, to receive donations to administer & deal with them.

(d) To do all other such acts and things as may be necessary to the attainment of the aforesaid objects as may fall within the purview of the section 20 of the Societies Registration Act, of 1860.

4. The trust shall have a succession but shall have common seal and shall sue and be sued by the said name.

5. All the Income of Trust shall be utilized only for the betterment of the Trust and its aims and objectives.

### 6. OFFICERS OF THE TRUST.

The following shall be the office bearers of the trust:-

1. President.
2. Vice -President.
3. Secretary.
4. Treasurer.
5. Members : All the 6 remaining Founder Trustees.

7. a) The President, Vice- President , Secretary & Treasurer shall be elected for 5 years by the Trustees . A further period for 5 years can be extended by the majority votes of the founder trustees. The Election will be by way of 2/3 Majority of founder Trustees. The total founder Trustees will be members of the Managing Committee(Trust).

b) They shall be entitled to enjoy such privileges as honorarium as the Trustees may decide from time to time.

c) The meeting of the trust will be called by the Secretary with prior approval of the President. The notice of the meeting will be served on the trustees with three days time.

#### 8. PRESIDENT:

The President shall be elected for 5 years term and shall be eligible for re-election by the founder Trustees.

The powers and duties of the President shall be:-

- i) To preside over the meeting of the Trust.
- ii) To see that this constitution, Rules & Regulations are faithfully observed.
- iii) To be responsible for the better finances, management and progress of the Trust and will have full control over the working of management of the Institutions and Trust.
- iv) The President of this Trust shall be fully competent to constitute and dissolve any committee which is constituted later on whatsoever within the constitution.
- v) He is fully empowered to sanction any amount against the approved budgetary provision.
- vi) The President shall be ex-officio chairman of all the approved committees and sub-committees.
- vii) The President will have all the powers to call upon the managing committee as well as general body in emergent situation.
- viii) To appoint, dismiss, transfer, promote employee(s) or otherwise punish the employees(s) of the Trust / all the branches and institutions, which must be approved by the majority votes of the trustees. The President can appoint any employee if needed in emergency. He can revoke any action taken by any office bearer or authority of the institution or institutions.
- ix) The president may draw amounts from the bank accounts under the counter signatures of Secretary and Treasurer.

#### 9. VICE-PRESIDENT:

In the absence of the president, the Vice-President shall carry on the duties of his office and he/she shall preside over meetings of the Trust.

## 10. TREASURER:

The power and duties of Treasurer shall be as under:

- i) He shall be responsible for regular and proper maintenance of the accounts of the Trust and all its branches and institutions.
- ii) To prepare and present the budget estimates, audited accounts of the trust on due date.

## 11. SECRETARY:

He shall be the principal executive officer of the trust for the purpose of law suits under section 6 of the societies registration act.

He shall have the power to delegate any of his powers and duties to any staff member or members.

The powers and duties of secretary shall be -

- i) To execute the work of the trust.
- ii) To call meetings of the trust with prior approval of the president and keep the record of the proceedings of the meetings.
- iii) To realise subscription, donations, contributions, loans, fees etc. and issue official receipts with counter signatures of the president and the same will be deposited by him in the bank account of the trust on the very day or the next working day.
- iv) To suspend any servant of the trust drawing pay below Rs. 4000/- p.m.(rupees four thousand only) under intimation to the president.
- v) To keep an imprest money or balance upto Rs.40000/-(rupees forty thousand only) in cash.
- vi) To carry out all the official corresponding on behalf of the trust.
- vii) To be fully empowered to sanction bills, cash memos upto Rs.10000/-(rupees ten thousand only) against the budgetary provisions but such total amount will not exceed Rs.50000/- in a month.
- viii) To manage, supervise and control all the departments, institutions and activities of the trust under the guidance and approval of the president.
- ix) To use such other power and to perform such other functions as may be necessary for the due discharge of his duties as secretary of the trust.
- x) He is full empowered to enter into any contract agreement for furtherance of large interest and welfare of the trust with the prior approval of the majority votes of the trustees.

## 12. There shall be following three class of members :-

- a. Founder Trustees.
- b. Life Members.
- c. Honorary Members.

#### FOUNDER TRUSTEES:

The founder trustees will be 10 only. Each founder trustee will donate a sum of Rs. 31000/- for the initial working of the trust. The name and addresses of all the founder trustees have been given in this trust deed. In case of any vacancy due to death, voluntary retirement, the vacancy will be filled from his/her legal heirs but if there is no legal heir then the Managing Committee is at liberty to co-opt any person from the life members as founder trustee in his or her place. But in case of disputes among the legal heirs for the membership of the founder trustee, then the Managing Committee can co-opt any legal heir as founder trustee.

#### LIFE MEMBERSHIP :

Any individual not below the age of 18 years with sound mind and is in agreement with aims and objectives rules and regulations of the Trust shall be eligible to become life member of the Trust subject to the approval of the President without the power to vote. The desirous persons shall have to apply to the secretary on the prescribed membership form with application fee of Rs. 5100/- not to be refunded or adjusted in any case. The President shall have the full power to accept or reject the form with or without any reason. The decision of the president shall be final. The Trust or president can assign any type of work of the Trust or institutions to any life member (s).

#### HONORARY MEMBERS :

Any person who is considered to prove beneficial to the Trust may be co-opted as honorary member by the president without the power to vote. He may be assigned any work to do by the president or Trust.

#### 13. REMOVAL FROM MEMBERSHIP:

Subject to the approval of the President any officer or member shall be removed from the membership of any council or committee on any one of the following grounds :-

- a) For acting in any way prejudicial to the interest of the Trust.
- b) Have failed to perform the duties entrusted to him.
- c) Have failed to attend the three consecutive meetings.

14. Assets and liabilities accrued by any authorized office bearer of the Trust, all its branches and institutions will be the property of the Trust. If the trust fails due to some or other grounds, it shall be merged in some charitable organization having the same aims and objectives by the resolution of the trustees passed by 2/3 majority.

16. AUDITING OF ACCOUNTS

The accounts of the trust of all its branches and of all its institutions shall be kept separately and shall annually be audited by the chartered auditors appointed by the president with consultation of secretary. Such audited accounts shall be placed at the annual meeting of the trust for its approval.

17. ALTERATION IN RULES

These rules and regulations may be amended and altered by the trust but the new rules and regulations shall not be inconsistent with or contrary to the aims and objectives of this constitution.

18. If any question arises whether any person has been duly elected or appointed or is entitled to be member of any authorities or other body of the trust the matter shall be referred to the Managing Committee whose decision will be final.

19. All properties (Moveable or immovable by the way of gift, endowment, purchase or otherwise) shall be acquired in the name of the trust and all such properties when so acquired shall vest in the Trust.

20. If the trust fails to acquire its aims and objectives then the managing committee has the powers to sell its assets including moveable and immovable properties and the proceeds of such sale will be donated to other trust having the same aims and objectives decided by the majority votes of the trustees.

21. All the Civil suits by or against the trust or its district offices or institutions shall be filed only in the Civil Courts at Ambala.



WHEREAS initially there were 9 Founder Trustees with a provision in Clause No.15 of the Trust that 10<sup>th</sup> Founder Trustee will be added and decided by the Board of Trustees later on. Keeping in view this provision in the original Trust Deed, the Board of Trustees vide its Resolution No.18.1 dated 01.06.2008 approved the name of Sh. Sushil Kumar Gupta son of Sh. Om Parkash resident of 45-A, Sharda Nagar, Ambala City as the 10<sup>th</sup> Founder Trustee of the said Trust.

AND

WHEREAS to carry out the aims and objectives of the Trust in more efficient way, the Founder Trustee/Settlor with the consent and authorization of other Founder Trustees executed a Supplementary Trust Deed by making additions in the Rule and Regulations and in consonance with Clause 17 of the Rules and Regulations and the said Supplementary Trust Deed was executed and got registered as a Supplementary Trust Deed dated 31.07.2007. It was got registered vide document No. 2128 dated 31.07.2007 which was pasted in Additional Bahi No. 1, Jild No.7546 on page No.31 to 32.

AND WHEREAS to further carry out the aims and objects of the Trust, a necessity arose to write another Supplementary Trust Deed to carry out the aims





and objects of the Trust in more effective manner, so the Settlor of the Trust with the authorization of other Founder Trustees executed and got registered another Supplementary Trust Deed dated 14.09.2009 and the same was got registered as document No.2676 dated 14.09.2009 pasted in Additional Bahi No.1 Jild No.7864 on Page No.67 to 68.

WHEREAS both the Supplementary Trust Deeds were duly executed by the Settlor with the consent of the other Founder Trustees and both these Supplementary Deeds are now part and parcel of the original Trust Deed.

AND

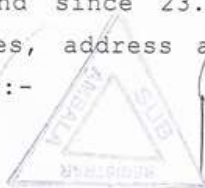
WHEREAS three Founder Trustees namely Sh. Ram Ji Lal son of Sh. Budh Ram resident of H.No.1101/12, Milap Nagar, Ambala City, Naresh Kumar son of Sh. Ram Ji Lal R/o H.No.1101/12, Milap Nagar, Ambala City and Smt. Promila Devi wife of Sh. Naresh Kumar R/o H.No.1101/12, Milap Nagar, Ambala City, who were the Founder Trustees of Shiv Gourakh Nath Education Trust Ambala City, took voluntarily retirement from the said Trust and resigned as Founder Trustee of the said Trust on their own sweet will and without any pressure from any corner. They submitted their applications as well as their affidavits regarding their resignation /voluntarily retirement. Even all the legal heirs and family members of the said three Founder Trustees refused to accept any trusteeship or membership in the said Trust and all the three above said persons



submitted their retirement/resignation from the said Trust with the consent of all their legal heirs and family members. Their applications for retirement along with their affidavits were put up in the meeting of the Trust held on 28.08.2009 and all the Founder Trustees unanimously accepted and approved the voluntarily retirement of the above said three persons w.e.f. 24.08.2009.

AND WHEREAS due to their retirement, three vacancies of Membership of the Founder Trustees occurred in the Trust and in line with the original intent of the Settlor, matter to fill up the vacancies was put up in the meeting of the Trust which was held on 23.09.2009. The founder trustees as per their unanimous resolution adopted three persons namely Sh. Suresh Kumar son of Sh. Om Parkash R/o H.No.45-A, Sharda Nagar, Ambala City, Smt. Geetika Gupta W/o Sh. Sushil Kumar R/o H.No.45-A, Sharda Nagar, Ambala City and Sh. Yogesh Gupta son of Sh. B.S. Gupta R/o H.No.6-B, Shivaji Park, Yamuna Nagar, as Founder Trustees in the said Trust against the three vacant posts.

WHEREAS the names of the three voluntarily retiring trustees continue in the list of Founder Trustees of the original Trust Deed and whereas three new Trustees who have faith in the objects and rules of the Trust, have been appointed as Founder Trustees to carry out the aims and objects of the Trust more efficiently and since 23.09.2009 Clause No.15 which describes names, address and age of Founder Trustees reads as under:-

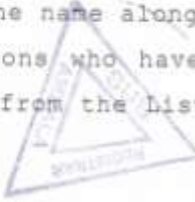
**"2. OFFICE**

Om Parkash R/o H.No.45-A, Sharda Nagar, Ambala City to amend and alter the original trust deed in consonance with Clause-17 of the Rules and Regulations of the original Trust Deed and this amendment is made with the consent of all the Founder Trustees by the Settlor and in line with the original intent of the Settlor. The objects of the Trust are not being interfered in any manner.




